**INVITATION TO APPLY
FOR ELIGIBILITY AND TO BID**

1. The **OPTICAL MEDIA BOARD** through the **BIDS and AWARDS COMMITTEE (BAC)** invites potential Bidders to apply for eligibility and, if subsequently eligible, to bid for:

a. Name of Project : Purchase of One (1) Light Delivery Van – Four or Six-Wheel Light Cargo Vehicle With Closed Delivery Van-Type Body

Brief Description : Gross Vehicle Weight: 4,500 to 6,000 kg.

Common-Rail Direct Injection, Blue Power
Diesel Engine

b. Approved Budget : Php 1,550,000.00

c. Funding Source : Regular Agency Fund CY 2018

2. Bids received in excess of the ABC shall be automatically rejected at bid opening.

3. Bidders should have completed, at least one (1) contract that is similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

4. Bidding will be conducted through open competitive bidding procedures as specified in the Implementing Rules and Regulations-A (IRR-A) of Republic Act No. 9184 (R.A. 9184), otherwise known as the Government Procurement Reform Act. All particulars relative to Eligibility, Bid bond, Performance Bond, Pre-Bid Conference, Bid Evaluation and Award of Contract shall be governed by the provision of this Act.

5. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

June 4, 2018	-	Opening of Bids, 1:00 P.M.


9. The Pre-Bid Conference shall be open to all interested parties.
