**RECOMMENDING THE APPROVAL OF THE ANNUAL PROCUREMENT PLAN OF THE OPTICAL MEDIA BOARD (OMB) FOR CALENDAR YEAR 2025**

---

**WHEREAS**, pursuant to Section 7.2 of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, no procurement shall be undertaken unless it is in accordance with the approved Annual Procurement Plan (APP), including approved changes, and must be consistent with the duly approved yearly budget of the Procuring Entity (PE);

**WHEREAS**, Section 7.3.1 of the RA 9184 and its IRR states that the APP shall be formulated only upon issuance of the budget call in the National Government Agencies, the Procuring Entity shall prepare its indicative APP for the succeeding calendar year to support its proposed budget taking into consideration the budget framework for that year in order to reflect its priorities and objectives;

**WHEREAS**, Section 7.3.4 of the RA 9184 provides that the Project Procurement Management Plan shall be submitted to the Procuring Entity's Budget Office for evaluation in order to ensure consistency with the Procuring Entity's budget proposal and compliance with existing budget rules. The PPMPs included in the budget proposal shall be forwarded to the BAC Secretariat for consolidation into an indicative APP, and to the BAC for final recommendation of the appropriate procurement modality;

**WHEREAS**, on 09 December 2024, Mr. Dennis Lorenzo B. Pinlac was designated as the OIC Chairperson and CEO of the OMB through a memorandum from the Office of the Executive Secretary. In the said memorandum, the powers and functions associated with the designation of OIC Chairperson and CEO Pinlac specifically include the designation of being the Head of Procuring Entity in matters related to procurement and financial transactions of the OMB;

**WHEREAS**, on 07 January 2025, OIC Chairperson and CEO Pinlac reconstituted the OMB's BAC through the Office Order No. 2025-01-001.

**WHEREAS**, upon the issuance of the Office Order No. 2025-01-001 dated 07 January 2025, the BAC Secretariats immediately consolidated the PPMPs from all Offices, Divisions, Units, and Committees of the Procuring Entity to develop the APP CY 2025;

**WHEREAS**, the BAC Secretariat presented to the BAC the proposed CY 2025 APP for the determination and finalization of the modes of procurement and schedule of procurement activities in accordance with RA 9184 and its IRR and consistent with the approved budgetary allocation;

**WHEREAS**, upon careful review, evaluation, and deliberation, the proposed CY 2025 APP was found compliant with the provision of Republic Act 9184 and consistent with the approved budget allocation of the OMB for the year 2025;

**WHEREAS**, Section 7.4 of the same Rule requires the approval of the HoPE for the APP;

**NOW WHEREFORE**, upon careful review and evaluation, **WE**, the members of the OMB-BAC, hereby **RESOLVE** as it is hereby **RESOLVED** to recommend to the Head of Procuring Entity (HoPE), **OFFICER-IN-CHARGE MR. DENNIS LORENZO B. PINLAC, CSEE**, the approval of the Annual Procurement Plan for Calendar Year 2025.



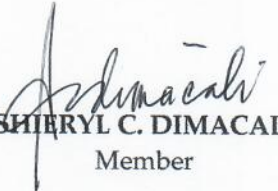
