1. Can the delivery schedule be relaxed to Ninety (90) working days instead of within thirty (30) to forty-five (45) working days upon receipt of the Notice to Proceed	No, the Agency shall stick with its original delivery schedule as the Agency has its own fiscal target.
Is an OMB Dealer License acceptable in lieu of a Distributor License for post-qualification requirements?	Yes, the OMB Dealer License is allowed, provided that the supplier attaches the contract with their distributor and/or importer. Further, the contract with Distributor and/or Importer must likewise be valid from the time of bidding and until actual delivery of laptops procured. The mentioned dealer / importer / distributor licenses must all be valid from the time of bidding until actual delivery of laptops procured.
3. Is an OMB Retailer License acceptable in lieu of a Distributor License for post-qualification requirements?	Yes, the OMB Retailer License is allowed, provided that the supplier attaches the contract with their distributor and/or importer. Further, the contract with Distributor and/or Importer must likewise be valid from the time of bidding and until actual delivery of laptops

Office Home & Business 2024, to ensure long-term usability, compatibility with government systems, and compliance with licensing requirements.	The Agency clarified during the Pre-bid Conference that the Microsoft Office, which must be pre-installed and activated, is Microsoft Office 365 or 2021.
